lunk Science is No Substitute for Smart Pesticide Policies

ave you ever heard the joke about dihydrogen monoxide? It's a dangerous chemical fatal when inhaled, causes severe burns, used in nuclear power plants, and contributes to the greenhouse effect. Politicians and citizens around the globe have declared their support for a ban on dihydrogen monoxide after being approached by 'activists" with petitions and alarming factsheets about the dangers of the chemical.

The punchline? Dihydrogen monoxide (H2O) is just another name for water.

When many people hear the word 'chemical," it sets off alarm bells. Never mind that everything we see and touch is a chemical of one kind or another. But what about manmade chemicals? In fact, as any farmer can tell you, manmade chemicals are absolutely essential to modern agriculture. Synthetic fertilizers and modern pesticides were an essential part of the Green Revolution, which has likely saved over one billion people from starvation since the 1940s.

Everyone knows that manmade chemicals can sometimes have unforeseen effects on the environment. That's why industrial. commercial, and consumer chemicals are today subjected to the greatest degree

of scrutiny in human history. Even when scientific evidence points to the safety and effectiveness of chemicals, many people are still wary. This is completely understandable – who has the time to read 20 scientific studies before going shopping? However, when governments have these sorts of knee-jerk reactions, the result is always bad policy.

This was recently highlighted by the editors of Maclean's magazine, who wrote in March that '(pesticide) bans, encouraged by lobby groups ranging from family physicians to environmentalists, rest not on competing scientific evidence, but rather a vague unease about chemicals in general."

In fact, pesticide bans often produce unexpected results, sometimes with greater damage to the environment. Since the government of Ontario banned pesticides, the number of artificial turf fields in the province has exploded. Plastic grass is hardly environmentally friendly, and its lack of an ecosystem often leads to disgusting results – as sweat, blood, and other bodily fluids simply fester in the turf. Maclean's reports that regular disinfection with industrial-strength chemicals is currently recommended for all artificial turf fields.

Junk Science is No Substitute for Smart Pesticide Policies



Or consider the weed-killer debacle in Quebec. The case centered on 2,4-D, the most widely used herbicide on the planet, which has been thoroughly studied since its development during the Second World War. It's used in well-known products such as Weed-B-Gon MAX, Trillion, and Killex. Various regulatory authorities – including Health Canada, the EPA, and the European Commission – have concluded that pesticides containing 2,4-D do not pose an unacceptable risk to human health or the environment, as long as they are used properly.

Nonetheless, the pesticide has been banned in many parts of North America, including Quebec. In 2009, the government of Quebec declared that weed killers containing 2,4-D were possibly carcinogenic, despite Health Canada's statements to the contrary. This sparked a ban on a number of non-crop uses, and manufacturer Dow

AgroSciences launched a NAFTA challenge.

Last year, in a balanced decision, the government of Quebec was finally forced to concede that its ban on 2,4–D did not rest on scientific evidence. Dow AgroSciences agreed to drop its suit for damages, while the ban was upheld on constitutional grounds. While it was a victory for the right of governments to regulate pesticides, it was also a step forward for science-based policy, instead of fearmongering and junk science.

Canada's vegetation managers are not opposed to government regulations that are genuinely intended to improve the lives of Canadians. However, government policies should be built on a foundation of scientific evidence, rather than knee-jerk reactions to bogeyman chemicals.

President of Dow Agrosciences Canada Jim Wispinki's Address

During the 2012 AGM the president of Dow AgroSciences Canada Jim Wispinski reitterated the need for science based regulation and Dow Agro Science's sucessful efforts to reverse a 2006 ban in Quebec on products containing 2,4-D.

In the settlement agreement, Dow AgroSciences LLC will waive its legal actions and claims against the Government of Canada under NAFTA. In addition, Section 3 a) of the settlement agreement, states:

'the Government of Quebec agrees that products containing 2,4-D do not pose

an unacceptable risk to human health or the environment, provided that the instructions on their label are followed, as concluded by Health Canada's Pest Management Regulatory Agency ('PMRA") in its May 16, 2008, decision on the re-evaluation of 2,4-D."

'This settlement is positive for our company, our value-chain partners and most importantly, our customers. Quebec has agreed with the federal government's findings as to the safety of our product when used correctly. This is consistent with regulatory findings in the United States and in the European Union" said Jim Wispinski, President and CEO of Dow AgroSciences Canada Inc.

We also extend our appreciation to the Government of Canada in reaching this settlement which avoids a lengthy and costly NAFTA case," added Wispinski.

Some industry advocates believe this is the first of many reversals regarding non science based regulation on herbicides. Evidence coming out of Ontario's experience shows mixed reviews and sometimes disaterous alternatives.

The detrements of allowing invasive species to prosper or subsituting natural grasses for industrial plastics and disinfectants did not seem to be a better solution. WSSA's "Our View" - A Warning for those Practicing Multi-Application Programs.

The WSSA has released a journal article containing a clear message against muliple applications of glyphosate products in a single growing season. A noticable escalation in weed resistance to glyphosate including that of Kochia in southern Alberta should be a clear reminder to cycle chemicals and switch to a single application program. Alberta Environment has released a new best practices document for weed control on industrial sites. This document will work to serve as framework for operators, applicators and stakeholders managing industrial sites. GROWING YOUR BUSINESS WITH CONFIDENCE





